PUBLIC HEARING AND COMMENT PERIOD

Atmos's Application for Rate Case Increase

Atmos Energy Corporation ("Atmos") filed an Application with the Kansas Corporation Commission ("Commission" or "KCC") on July 25, 2025, Docket No. 26-ATMG-026-RTS.

Public Hearing

The Commission has scheduled a public hearing concerning Atmos's application, requesting a rate increase. This hearing will provide information about Atmos's application, including the potential impact on customers' bills, as well as an opportunity for customers to ask questions and to present comments for the Commission's consideration.

The public hearing typically consists of two parts: During the first part, representatives of Atmos, KCC Staff and the Citizens' Utility Ratepayer Board (CURB) will give short presentations about their roles in this docket. Each party will summarize the issues involved and will be available to answer customers' questions pertaining to the application. In the second part of the public hearing, customers may make formal statements to the Commission concerning the application. However, the Commission may determine how to best accommodate the public participation in this proceeding.

No registration is required for viewing only.

The KCC has until March 24, 2026, to make a decision on the proposed rate increase in this proceeding.

Atmos's Application

Atmos Energy Corporation ("Atmos") has filed an Application with the Kansas Corporation Commission ("KCC") requesting a \$19.1 million revenue requirement increase over rates set in its most recent rate case filed from 2022. The Company points to several factors such as increases to operating and maintenance expenses, updated depreciation rates, a Rate of Return increase to 10.80%, and expiration of credits associated with excess deferred income taxes as drivers for the requested increase.

Atmos Energy serves approximately 140,000 customers, including 130,000 residential customers. Atmos proposes increasing the fixed monthly Customer Charge by \$5.25 for Residential customers and \$12.00 for Commercial customers. If fully approved, the estimated bill impact for an average residential customer is \$9.12 per month.

Along with the requested rate increase, Atmos is proposing several modifications to its tariffs. Atmos has proposed the creation of a new Tax Rider Tariff for use to refund or collect tax revenue based on changes to state and federal tax laws. The Company intends to use the rider to respond to rate impacts associated with changing tax liabilities. Additionally, Atmos requests changes regarding Electronic Flow Measurement for certain transportation customers to make those customers responsible for costs to replace or upgrade equipment.

The Company is also asking for approval to file an abbreviated rate case following the conclusion of this docket to review additional actual plant investments, rather than utilizing estimates, for inclusion in rates.

Evidentiary Hearing

The Commission has scheduled an evidentiary hearing on the application for Monday, January 26, 2026, through Wednesday, January 28, 2026, beginning at 9:00 a.m. Central.
